## 2-Step TB Process

State regulation for Home Care requires PCSPs to have TB testing and GSIL requires *all* of its home care employees to have the same TB testing. This process is officially called the 2-step Mantoux Tuberculin Test.

### **2-step Process: (The TB facility must be visited 4 times.)**

1. Make 1<sup>st</sup> plant appointment with a facility that is contracted by GSIL – a listing is attached.
2. Have 1<sup>st</sup> TB test planted. Make appointment for 1<sup>st</sup> read.
3. Go back to facility within 48 to 72 hours to have TB test read. Make appointment for 2<sup>nd</sup> plant.
4. GSIL must receive results of the 1<sup>st</sup> TB testing in order for the employee to start work.
5. Wait approximately one week – or the length of time the facility deems necessary.
6. Go back to facility to have 2<sup>nd</sup> TB test planted. Make appointment for 2<sup>nd</sup> read.
7. Go back to facility within 48 to 72 hours to have TB test read.
8. GSIL must receive results of the 2<sup>nd</sup> TB test.
9. The 2 Step process is now complete.

### **Other Important Information:**

1. GSIL only pays for 2 TB plants/reads.
2. It is encouraged that employees get copies of their testing.
3. It is the employee's responsibility to contact GSIL regarding GSIL receiving their TB test results.
